Model 61021, size Adult Universal, manually/automatically inflated "RECREATIONAL INFLATABLE", Type V PFD with Type II performance when fully inflated, with integrated harness.

Yoke style construction with partly fabric covered inflation chamber, using 33 gm manually/automatically activated CO2 inflation system with cylinder seal indication, for persons weighing more than 36 kg (80 lb), with chest size 76-132 cm (30-52 inches).

This is a special use device, Type V PFD, approved for use only by persons knowledgeable in the proper use and release of the chest harness and only as a substitute for Type II PFD. Approved only for persons at least 16 years of age and only when used in accordance with the owner's manual and harness label (since the harness can cause injury or death if not properly used). Not approved for use on personal watercraft, for white water paddling, or for water-skiing, knee boarding, or similar towed uses. Not approved to meet carriage requirements on commercial vessels.

Has a viewing window constructed of clear PVC or vinyl, minimum 0.030 cm (12 mils) thickness.

The approval is subject to any conditions noted on this Certificate and in the applicable laws and regulations governing the use of the item on vessels subject to Coast Guard inspection or on other vessels and boats.

Consideration will be given to an extension of this approval provided application is made 3 months prior to the expiration date of this Certificate.

The approval holder is responsible for making sure that the required inspections or tests of materials or devices covered by this approval are carried out during production as prescribed in the applicable regulations.

The approval of the item covered by this certificate is valid only so long as the item is manufactured in conformance with the details of the approved drawings, specifications, or other data referred to. No modification in the approved design, construction, or materials is to be adopted until the modification has been presented for consideration by the Commandant and confirmation received that the proposed alteration is acceptable.

**NOTICE:** Where a manufacturer of safety-at-sea equipment is offering for sale to the maritime industry, directly or indirectly, equipment represented to be approved, which fails to conform with either the design details or material specifications, or both, as approved by the Coast Guard, immediate action may be taken to invoke the various penalties and sanctions provided by law including prosecution under 46 U.S.C. 3318, which provides:
